We hope you enjoyed the festive season. This quarter we continued to be active in a number of areas which are highlighted in this edition of our newsletter.

Roundtable on Combating International Money Laundering

In January TI-UK partnered with Wilton Park and Allen & Overy to hold a roundtable meeting, *Building Public and Private Sector Consensus on Effective Measures to Combat International Money Laundering Activities*. The roundtable was attended by many high-level figures from the government, civil society and business.

This year the UK assumed the presidency of the G8. This roundtable was part of a wider effort by TI-UK to influence the UK's agenda as it chairs the G8 meetings this year. David Cameron has promised to put transparency at the forefront of his agenda for the G8. We will be writing to him to encourage a focus on money laundering and extractive transparency during the UK's presidency.

Annual Anti-Corruption Lecture with John Githongo

In December we held our Annual Anti-Corruption Lecture, kindly hosted by Clifford Chance. The lecture was given by renowned Kenyan anti-corruption campaigner John Githongo. He gave a fascinating speech on corruption in the west and the financial crisis as well as his experience fighting corruption in Kenya. A transcript of John's speech can be

All-Party Parliamentary Party on Anti-Corruption Panel Event

TI-UK board member Helen Garlick was a <u>keynote speaker</u> at the Anti-Corruption APPG panel event on money laundering, bribery and tax evasion in the Overseas Territories. Other speakers included Daniel Balint-Kurti from (Global Witness) and Joseph Stead (Christian Aid). The discussion provided an excellent forum to discuss an issue that will form an important part of the UK's agenda for the G8.

Launch of 2012 Corruption Perceptions Index

This year's Corruption Perceptions Index was released in December. The UK again failed to receive a top ten ranking mainly as a result of repeated political corruption scandals. The UK was ranked 17th out of the 176 countries surveyed. You can find out more about this year's Corruption Perceptions Index here.

Transparency International UK Defence & Security Programme (TI-DSP)

TI-DSP has been very busy. In October we launched our Defence Companies Anti-Corruption Index. The index gave an insight into what the 129 biggest defence companies around the world do and don't do to prevent corruption. It found that two-thirds of the world's biggest defence companies do not provide enough public evidence about how they fight corruption. The launch received extensive attention and was mentioned in over 100 articles across the world. Many companies have since contacted us for advice on how to improve their anti-corruption procedures. In January we launched the Government Defence Anti-Corruption Index. This index is the first ever review of corruption risk and corruption vulnerabilities in countries' defence sectors. The report found that 70% of governments fail to protect against corruption in their Defence Ministries and Armed Forces. The report was launched in Taiwan and has received extensive coverage across the globe. You can read more here
